# RESPONSE BY ATMIS POLICE COMMISSIONER CP HILLARY SAO KANU

Ghana is one of the Police Contributing Countries to ATMIS, with both IPOs and FPU's serving on the mission. What has been the Area of Responsibility of the Ghana Formed Police Unit (GFPU-3)?



The Ghana Formed Police Unit-3 (GFPU-3) is based in Baidoa, Southwest State of Somalia, basically to support ATMIS mandate in providing security for ATMIS Individual Police Officers (IPOs), when they go out for collocation, to train and mentor the Somali Police Force (SPF). Personnel of the GFPU-3 have also been providing support to our international partners, particularly the Humanitarian actors in the delivery of humanitarian assistance to the local communities. Also, they provided guard duties for AU and UN infrastructure installations. The GFPU-3 also provided operational training for the SPF, given that their unit is purely operational. This includes combat readiness, public order management in times of crisis and VIP escort for example during the visit of the UN Secretary-General Antonio Guterres to Baidoa last year, in which they performed exemplary well to ensure his security and safety. Additionally, they also provided security for the entire duration of the National Consultative Council (NCC). They have provided a lot of support to our counterparts-the SPF, for example they helped to jointly secure the Holy month of Ramadhan, last year.

# What contribution has the GFPU-3 made to the ATMIS Police mandate and the overall mission mandate?

Recently the GFPU-3 was able to engage their counterparts, the SPF in POM (Public Order Management). The trainees will in turn train their colleagues in POM. Part of the training included combat readiness and VIP protection. The personnel of the GFPU-3 have been supporting the SPF in these areas because they specialize in providing escort for VIPs and protection of civilians when it comes to crisis management. They have provided incredibly good and useful insights to the SPF personnel.

# As the ATMIS Police Commissioner, what is your general assessment of the performance of the GFPU-3 during their tour of duty?

They have done remarkably well because they have maintained discipline among themselves, other partners and even with the local counterparts they work with. They have maintained discipline and respect for human rights, respect for the local community, including respecting their culture and religion. There has never been any complaint brought against them for indiscipline. They have been executing their duties with the highest level of commitment and dedication. The GFPU-3 has done marvelously well in executing their duties, and because of this, at their medal parade, they received a lot of praise and commendation from the stakeholders.

# What message do you have for GFPU-3 personnel who are expected to rotate out of the mission soon after completing their tour of duty?

I want to congratulate them for a job well done. As they wind up their tour of duty, my message to them is that they should keep up with the hard work and maintain discipline wherever they go. They should be committed in their day-to-day work, and above all, I urge them to maintain the spirit of oneness in supporting Africa so that we can have stability and long-lasting peace on the continent. Finally, I want to send my sincere thanks and appreciation to the leadership of the Ghana Police Service as well as the Government and people of Ghana for deploying the Ghana Formed Police Unit to Somalia, to support the AU and the mandate of ATMIS, and for providing all the necessary logistics to enable them to discharge their duties in Somalia.

## ATMIS POLICE OPERATIONS AND FPU **COORDINATOR, DCP AHMED LATEEF FOR GHANA FORMED POLICE UNIT-3**



On: What contribution has the Ghana Formed Police Unit-3 (GFPU-3) made towards the fulfillment of the ATMIS Police mandate?

Ans: The Ghana Formed Police Unit- 3 (GFPU-3) is based in Baidoa, Southwest State, and the mandate of ATMIS Police is basically to support the Somali Police Force (SPF). However, apart from supporting the SPF, they are also supposed to support ATMIS, to provide support for AU and UN personnel and facilities and also support humanitarian actors whenever they are going out in the field. The GFPU-3, also provide security for ATMIS IPOs, and because of their versatility and professionalism, we have made tremendous achievements in terms of mentoring, training, and advising the Police in Southwest State. Also, during their tour of duty, the GFPU-3 deployed a platoon to Beletwevne in Hirshabelle State to support our activities there, which includes providing security for the IPOs in fulfilment of our mandate. Apart from that, they also conduct visibility and reassurance patrols, which has endeared them to the local communities because they see them on a daily basis. GFPU-3 has also supported the development of a training program meant to equip the Somali Police Force with FPU capabilities. They are at the forefront of developing a manual for the training that we are about to roll out. Additionally, they also provide security for their camp in Baidoa and for both the AU and UN staff in Southwest State and as of today we have not had any case of security breach, since their deployment. On average, the GFPU-3 deploys 97 personnel daily on various duties such as escort, internal quard, quick response, and night standby duties. This ensures the provision of adequate security and contributes to the fulfillment of the ATMIS Police mandate, and through their support, we have done very well in Baidoa. The achievements of the IPOs in Baidoa. have largely been due to the support of GFPU-3.

Qn: What impact has their tour of duty had on the ATMIS Police component?

Ans: They (GFPU-3) assist the IPOs to carry out their duties of training, mentoring, and advising, and without them the IPOs cannot go to the Team sites to collocate with their Somali counterparts. Additionally, they also provide security for the base camp

in Baidoa and also conduct visibility and reassurance patrols, though this is more of an implied activity, but it gives the local communities hope and confidence.

On: How has this impacted on efforts to restore peace and security, particularly in Baidoa, Southwest State and Somalia in general?

Ans: The security provided by GFPU-3 has enabled ATMIS IPOs to carry out their tasks in fulfillment of the ATMIS Police mandate. This has also been reflected in the way Somali Police officers in Southwest State of Somalia are discharging their duties. The support that the GFPU-3 offers to the IPOs is critical in ensuring that the Police in Southwest State are well trained and this will be reflected in the community relations. The police are crucial in any post-conflict environment and the ATMIS IPOs deployed in Baidoa, through the support of GFPU-3, have inspired confidence in their Somali counterparts. In short, GFPU-3 has enabled the IPOs do their job, which has impacted on the SPF, thereby endearing the Somali police to the community, ultimately contributing to peace. Also, the reassurance patrols help keep the criminals away, thus deterring crime. Additionally, the GFPU-3 has enabled humanitarian actors to deliver support to the communities by providing escort services during the delivery of relief assistance to local communities in need of humanitarian support. For example, during the recent El Nino rains, humanitarian actors visited a lot of places to deliver relief items, and all this was made possible through the support of the GFPU-3 personnel. So, by and large, you find the police in Southwest State are doing very well because of the impact of the IPOs, through the support rendered by the GFPU-3.





# GFPU-3 CONTIGENT COMMANDER – SUPT. ERIC ARGMORTER VAN-KOFI

The advance team of the Ghana Formed Police Unit-3 (GFPU-3), comprising 16 personnel under my leadership, deployed to the mission on 22 January 2023, having departed Ghana two days earlier. Upon arrival, the team proceeded, on the same day to Baidoa, the administrative capital of South West State.

In Baidoa, the team was received and briefed by the outgoing GFPU-2 Contingent Commander, Chief Superintendent of Police (CSP) Maxwell Antwi and the command staff about the security situation in the basecamp and Baidoa, as a whole.

The advance team immediately hit the ground running, understudying the outgoing team to facilitate a smooth handover and seamless continuation of operation duties.

The main body of the contingent, comprising 144 personnel arrived in Mogadishu on 7 February 2023 and straight away proceeded to Baidoa, and upon arrival, was also briefed on the security as well as the rules and regulations of the camp.

In November 2023, the GFPU-3 deployed a platoon comprising 32 personnel to Beletweyne, Hirshabelle State, to provide operational support, in line with an earlier request by the ATMIS Police Headquarters in Mogadishu.

#### **INDUCTION AND TRAINING**

A five-day induction training facilitated by personnel from the Mission Headquarters in Mogadishu was organized for the contingent to acquaint them with their new work environment.

Topics covered in the training included the ATMIS mandate, health, logistics, personal security, Somali people and culture, human rights, sexual exploitation and abuse (SEA), Improvised Explosive Devices (IED) awareness, SITREP (Situational Report), code of conduct, diversity, stress management, gender and the relationship between the various security partners-Ethiopia National Defense Forces (ENDF), ATMIS Individual Police Officers (IPOs), the Somali Police Force (SPF) and other stakeholders.

#### **BACKGROUND OF SOMALIA**

Somalia operates a federal system of government, with five Federal Member States (FMS). These include



Puntland, Galmudug, Jubaland, Hirshabelle and South West State of Somalia. The Federal Member States have been sectorized for security purposes, and Baidoa falls under ATMIS sector 3.

GFPU-3 is based in Baidoa and shares a common camp with the ENDF, the UK STAT (Somali National Army Training and Advisory Team), civil contractors and UN staff.

#### STRENGHT OF THE UNIT

GFPU-3 had a physical strength of 160 personnel, comprising 136 male and 20 female officers. During our tour of duty, two colleagues had to return home prematurely due to personal reasons.

#### **FULFILLING ATMIS MANDATE**

The GFPU-3 discharged its core duty of supporting the Somalia-led peace and security process. Other tasks undertaken included the provision of escort and protection for ATMIS IPOs during their visits to the various Team Sites to train, mentor and advise their Somali counterparts; protection of VVIPs; provision of escort and protection of humanitarian actors / agencies, and the protection of civilians, jointly with the SPF.

The contingent together with the SPF conducted joint confidence building patrols and helped secure the central business district in Baidoa, thereby enabling members of the public to go about their daily businesses

normally.

Additionally, the GFPU-3 in collaboration with ENDF and SPF provided security during elections and at other high level political events, including during visits of high-profile personnel, such as the UN Secretary General, Antonio Guterres.

#### **CAPACITY BUILDING AND TRAINING**

During our tour of duty, the personnel of GFPU-3 undertook various training courses, to enhance their capability and ensure efficiency. The courses included induction courses; IED threat mitigation, food safety and hygiene, ICT, environmental sanitation, fuel workshop, vehicle and checkpoints search, mental health and psychosocial support

and medical plaining and logistics, with many others undertaken in Mogadishu and in Nairobi, Kenya.

# SECURITY COORDINATING MEETING AT THE JOINT OPERATION COMMAND CENTRE (JOCC)

The Unit has participated in security coordinating meetings at various levels, with key stakeholders on a weekly basis, to coordinate and strategize on security issues in the region, with the focus being the activities of the militant group Al Shabaab.

#### **ACHIEVEMENTS**

The GFPU-3 registered several achievements. These include the provision of escort and guard services for ATMIS IPOs, thus enabling them to discharge their duties of training, mentoring and advising the Somali Police in the region, conducting confidence building patrols in the central business district of Baidoa, thus contributing to the overall peace and security in the area, and supporting humanitarian efforts.

However, the contingent also faced challenges. These included language barrier, muddy and difficult terrain especially during the rainy seasons, and occasionally having to venture out of the green zone, without military backup, while supporting humanitarian actors.







# CONTRIBUTION OF THE GHANA FORMED POLICE UNIT TO GLOBAL PEACE

The deployment of the Ghana Formed Police Unit-3 to serve under the African Union Transition Mission in Somalia (ATMIS), is a continuation of a long-held tradition of Ghana and particularly the Ghana Police Service (GPS) to contribute to Peace Support Operations, globally.

To this end, the GPS has a fully-fledged Formed Police Unit, whose first deployment was in 2015 in South Sudan and has since seen its personnel deploy to different missions, including in Somalia.

Originally established to deploy to international peacekeeping missions, the FPU has increasingly been used for internal operations. Within Ghana, it has been deployed to guard critical national security installations, as first responders in local crises across the country and in preventive deployment capacity during public assemblies.

Ghana, through its Formed Police Unit (GFPU), is one of the many Countries Contributing to the United Nations peacekeeping operations all over conflict-stricken countries in Africa and beyond, and ATMIS is no exception.

The intervention of the African Union in Somalia has played a critical role in helping restore peace and stability in the country, and the police have played a vital role in the ongoing effort to restore normalcy.

The arrival of the GFPU-3 in Baidoa, South West State of Somalia (SWSS) on 7 February 2023 under the leadership of the Contingent Commander, Superintendent of Police (SP) Eric Angmorter Van-Kofi, was testimony to Ghana's commitment to support peace initiatives in Somalia and the continent.

In my capacity as the deputy commander, my brief entailed supporting the commander in all aspects, to ensure that the contingent achieves operational success in the implementation of the ATMIS Police mandate, in our Area of Responsibility (AoR). This


support would be in administration, enforcement of discipline and supporting the operations of the contingent.

Additionally, my tasks entailed assuming command of the contingent in the absence of the Contingent Commander, to ensure continuity until such time when he would return.

Thus, all in all, my duties entailed deputizing the commander in all aspects, to ensure overall operational efficiency and success of the contingent, and executing any other tasks as assigned by the contingent commander.

In conclusion, the role of the deputy contingent commander, in a peacekeeping mission in Somalia is extremely demanding and challenging and requires among others, proper people management skills and a rational sense of judgment.

### **CAPACITY BUILDING AND** TRAINING IN THE MISSION



The Ghana Formed Police Unit-3 (GFPU-3) is the third contingent from Ghana to be deployed to serve on the AU peacekeeping mission in Somalia, to provide operational support to the Somali Police Force (SPF). However, the provision of this support requires a well-trained and committed team, thus the need for constant in-house refresher training courses. Part of the operational support includes providing security and maintaining law and order.

In addition to their operational duties, the GFPU-3 also engages in capacity building efforts through training and mentoring activities. This includes training Somali police officers on firearms handling, crowd control, human rights, and other essential skills needed for effective policing.

Through these capacity building efforts, the Ghana FPU-3 aims to help strengthen the Somali Police Force and contribute to the long-term security and stability of Somalia. The training provided by the Ghana FPU-3 personnel, is part of wider

efforts to professionalize the Somali police, enhance their operational capabilities, and improve their overall effectiveness in maintaining law and order.

Thus, during our tour of duty, the personnel of the GFPU-3 attended







several in-house refresher courses in diverse areas, organized by the African Union Transition Mission in Somalia (ATMIS) and the UN, to enable them deliver on their mandate.


These included Induction training; **Improvised** Explosive Devices awareness, Explosive Hazard Awareness Training (EHAT), Food Safety and Hygiene, Information Communication Technology, Environmental Sanitation, Fuel Workshop, Vehicle and Checkpoints Search, Mental Health and Medical Psychosocial Support, Plaining and Logistics and other

courses, in Kenya and Mogadishu. The courses were coordinated by the Induction and Training Unit from ATMIS Police Headquarters.

For example, the EHAT course which centered on officer safety helped in raising the alertness of the contingent personnel, especially when moving out of the base camp for duty since Improvised Explosive Devices (IED's) are the preferred weapon of choice of the militant group Al Shabaab, who often target the Somali Security Forces and ATMIS Personnel.

The Food Safety and Hygiene course was also another relevant program which immensely benefited the contingent, given that most of the food consumed in the mission area is preserved electronically.

Therefore, taking the people who matter through such a training program helped in proper handling, storing and cooking of food, thereby contributing to food safety and hygiene, crucial for the wellbeing and functioning of the contingent.



### **ENHANCING COMMUNICATION** IN THE MISSION

Communication is vital for the success of many undertakings, such as the peace keeping mission in Somalia. Ghana is one of the six Police Contributing Countries to the African Union Transition Mission in Somalia (ATMIS), alongside other countries, which include Kenya, Nigeria, Sierra Leone, Uganda and Zambia.

In keeping with its long-held tradition of supporting peacekeeping operations globally, Ghana has deployed both Individual Police Officers and a Formed Police Unit in Somalia, to serve with ATMIS.

However, our focus will be the Ghana Formed Police Unit-3 (GFPU-3), the third contingent to be deployed to the mission by Ghana, to offer operational support to the SPF. The communication unit responsible for maintaining communication channels within the GFPU-3, ensuring that information disseminated promptly and accurately to all members. This helped to enhance operational efficiency and coordination during the tour of duty in the peacekeeping mission.

The unit also played a key role in liaising with other units within ATMIS, as well as with our counterparts-the Somali police in Baidoa and other stakeholders.

Additionally, the communication unit was responsible for managing external communication, including media relations and public outreach activities.

This included projecting the activities of the contingent and promoting the understanding of the unit's mandate and objectives. Some of the activities

included the provision of escort services and internal events in the basecamp. Furthermore, effective communication helped to build and foster trust and cooperation with local communities and stakeholders.

During our tour of duty, personnel of the GFPU-3 communication unit attended several training courses to enhance efficiency. This included a strategic communication workshop for the ATMIS Public Information Officers, drawn from the civilian, police and military components, organized by the ATMIS Public Information Unit (PIU), held in Nairobi, Kenya, to hone our skills in effective communication of mission activities. The training was extremely beneficial.

Despite several challenges, the communications unit of GFPU-3 played a critical role in highlighting the activities of the contingent, thereby supporting its operations to ensure success.





# ATMIS SUPPORTS SOMALI POLICE FORCE DURING MONTH OF RAMADAN



In keeping with tradition, the Ghana Formed Police Unit -3 (GFPU-3) in April last year, donated food and non-food items to the South West State Police, during the holy month of Ramadan.

- 3. Supporting the host security


#### service, the Somali Police Force.

### **UNDERGOING INDUCTION TRAINING**



An induction training was organised for the Ghana FPU contingent in Baidoa by the Induction and Training Unit based at ATMIS Police headquarters in Mogadishu.

The training course covered various topics including the ATMIS mandate, health, logistics, personal security and safety. It also covered the Somali host community and their culture,

human rights, prevention of sexual exploitation and abuse.

Other topics covered were: Improvised Explosive Device (IED) awareness, situation reports, code of conduct, diversity, stress management, gender, and relations with other security partners, such as the Ethiopian National Defence Forces, Individual Police Officers,

the Somali Police Force and other stakeholders since the mission is a multinational one.

As a newly deployed contingent in the mission theatre, induction training helped personnel understand their roles better and adjust to the operational environment as early as possible.

### REPORT FROM THE OPERATIONS OFFICER

The Ghana Formed Police Unit Rotation Three (GFPU-3) commenced its operations in March 2023, soon after the completion of the contingent's two-week induction training course.

The Operations Officer in collaboration with Language Assistants (LAs) organised a oneweek familiarisation of Baidoa town for the contingent personnel.

BRIEFING: AUPOL Personnel are adequately and sufficiently briefed about the activities they have been assigned. They are urged to exhibit professionalism, discipline and alertness in performing the assigned tasks.

Additionally, AUPOL personnel are expected to be vigilant and always adhere to personal security and safety precautions. While on duty, personnel must report any unusual activity for immediate action or assistance.

DEBRIEFING: AUPOL Personnel are assembled for debriefing after returning from assigned duty. This is to determine whether there is any requirement to implement risk control, improve operational strategy and contribute to plans depending on intelligence gathered.

GFPU-3 performs its traditional core mandate of ATMIS operational tasks. AUPOL personnel embark on vigorous and effective confidencebuilding patrols within Baidoa and its environs to build public confidence in security.

GFPU-3 works alongside Individual Police Officers (IPOs) to provide operational capacity building to the Somali Police Force (SPF) at various police stations and posts within Baidoa town.

Furthermore, GFPU-3 provides VIP escort and protection for UN entities and ATMIS officials. For example, on 11 April 2023, GFPU-3 with other security partners provided maximum escort and protection to the UN Secretary-General, Antonio Guterres and his entourage during a visit to an Internally Displaced Persons (IDPs) camp in Baidoa.

In conclusion GFPU-3 diligently discharged the assigned duties in accordance with the ATMIS mandate in support of stabilisation efforts in Somalia ahead of ATMIS transition in December 2024. The contingent lifted the flag of the motherland and the Ghana Police Service.





### **UN SECRETARY-GENERAL VISITS SOUTH WEST STATE**
